STATE BUDGET UPDATE

California Budget Deficit

Lagging revenue continues to drive California budget deficit as deadline nears







..."Revenues from income, sales and corporate taxes are still running \$6 billion behind what Newsom's January budget projected for the current fiscal year, meaning that cumulative deficit will be substantially more than the \$38 billion Newsom's proposed budget assumed".

CSU Multi-Year Compact

- ✓ Ongoing State General Fund increases of 5%
- ✓ 5 years from FY 2022-23 through FY 2026-27

Governor's Proposal for CSU Compact

- No new base (ongoing) or one-time funding in 2024-25 from the State
- Compact deferral

2024-25 CSU distributes \$240 million one-time from CSU central reserves to the campuses (no impact to campus reserves)

2025-26 State reimburses CSU \$240 million one-time

State appropriates \$240 million ongoing (year 3 of compact)


State appropriates ~\$252 million ongoing (year 4 of compact)

Proposal would deliver the same level of funding per year, per the compact

CSUSM Budget History - How did we get here?

Challenging History

- A few years in the red before FY 16/17
- Campus not fully funded for actual resident enrollment FTES

COVID Pandemic

• Enrollment declines resulted in reduction of baseline budget Tuition revenues with gap covered from CSUSM Central Reserves. Divisions' Budgets not impacted

General Salary Increases (GSIs)

- Used to be fully funded from State
- 7% and one-time payouts for FY 2022-2023 partially funded by campus
- 5% for FY 2023-2024 and another 5% FY 2024-2025 largely funded by campus

Existing challenges/risks

State Funding is uncertain

> Anticipated State budget shortfalls resulted in deferral of FY24/25 Compact for CSU

Campus must maintain year-over-year enrollment growth to ensure funding based on new FTES funding model

> Future CA High School enrollment/graduates projected to decline over the next decade

Campus mandatory costs including utilities, insurance, and benefits, continue to increase, not base funded

> Currently using one-time funding from CSUSM Central Reserves

Several years of funding ongoing commitments with one-time budget have lowered OpFund balances

> Division Carryforward balances have also decreased since COVID

CSUSM Incremental Budget Model

Focuses mainly on changes from existing (prior year) Operating Budget:


- Incremental sources anticipated new funding
- Incremental uses anticipated new costs
- Provides stability and predictability to Divisions
- Divisions typically keep their carryforward balances

So, what is our **Operating Budget** and what are anticipated **incremental changes**?


